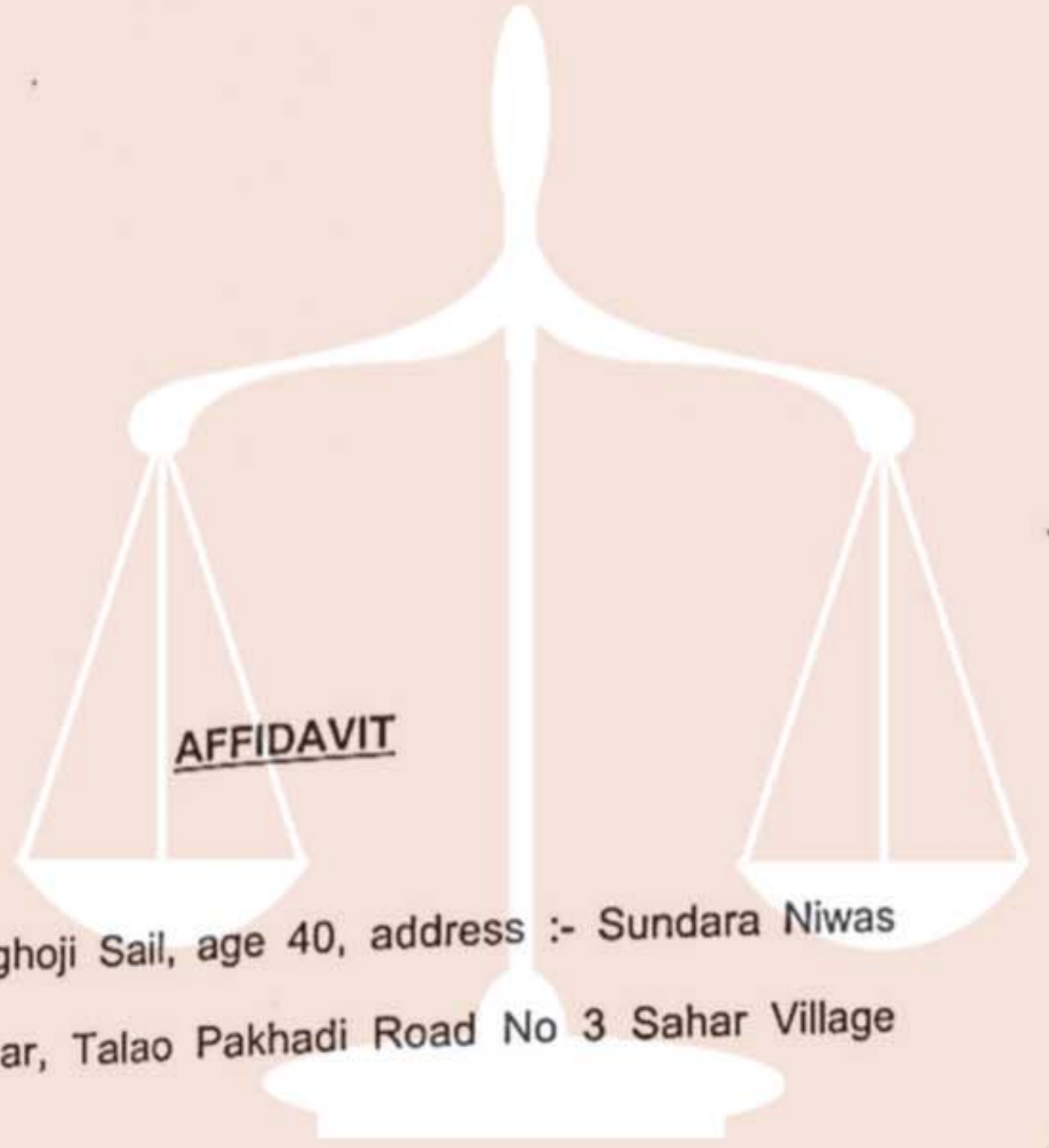

AFFIDAVIT

I Prabhakar Raghoji Sail, age 40, address :- Sundara Niwas room no.1 Durga Nagar, Talao Pakhadi Road No 3 Sahar Village Andheri east.

1) I say that, I was employed by Kiran Prakash Gosavi as his personal bodyguard on 22/07/2021 and worked for him since then. I was first shifted to the house of K P Gosavi on 30/07/2021 at Aadhar Society second floor Vijay Nigari Hiranandani estate, Waghbil Naka Ghodbunder road Thane.

2) K P Gosavi told me that he had an import export business .I was assigned duty as his personal bodyguard and accompanied him on his meetings etc.

3) On 8th Sept 2021, K P Gosavi shifted to, Vashi sector 28, plot no 23, flat no 1, ground floor with all my clothes and belongings continued doing duty as personal bodyguard.

4) On 27th sept 2021 K p gosavi left for Ahmedabad by road by innova no MH 12 JG 3000 white colour. I was told to stay back at vashi.

5) On 1st October 2021 at about 9 45 pm he called me and said that I should be ready by 7 :30 am and that he has left. On 2nd October at about 7 35 Kiran Gosavi called me and said that he transferred 500 Rs to my gpay account and told me to that he is sending me a location on whats app, and told me to come to that location. I reached CST station at 8:45 pm and when I saw the location on whats app it was shown as NCB office. I reached there by taxi and saw white Innova car MH -12 -JG- 3000 parked Opp. NCB office, I asked the driver Vijay Suryavanshi as to where is K P Gosavi. He told me that K P. Gosavi, is in NCB office and as he is in a meeting with NCB official. I was with the driver at about 10:00 am Kiran Gosavi called the driver and came down with NCB officer for NCB office. Kiran Gosavi and the said officer left in the said Innova and instructed me to wait there itself.

6) At 12 :00 pm K. P. Gosavi called me and instructed me to come at green gate and wait. I accordingly went there he and me got in the car and went ahead and brou rolls, cold drinks brought some frankie rolls , water and cold drinks. We went back to





green gate and went inside. We went near boarding pad and I was told to distribute the food. I distributed the frankie rolls to Sameer whankade and other staff . I was thereafter told not to leave the premises and was instructed to wait at the waiting area for the cruise near green gate.

- 7) At about 1 : 23 pm Kiran Gosavi sent some photographs on my whats app and told me to keep a watch and identify the people in the photographs and to further inform him that if any of the said persons are coming to board the cruise through green gate.
- 8) Accordingly , I was waiting, I identified one person from the said photograph and informed him that he has boarded bus no 2700 on whats app. On 4 :23 he replied to me that said person who I identified is caught and that 13 people are arrested.
- 9) I was still waiting there till about 7 :00pm. Kiran Gosavi called me and told me to get the Innova car and specifically told me to tell CISF officers that Sameer Wankhede has asked them to allow the Innova car. However, they refused and told to get the car from Yellow gate. However, again the Yellow Gate CISF officials did not leave the said car and hence K.P Gosavi came out himself on foot and sat in the car and changed his clothes and he again entered green gate.

10)At about 10 30 pm I was called K P Gosavi in the boarding area and I saw Aryan Khan in one of the cabin at the cruise boarding area . I saw on girl , Munmumn dhamecha and few others with NCB officisals.





11) At about 12 :30 pm Kiran Gosavi accompanied by NCB official took aryan khan in his whit Innova to NCB office. I reached NCB office walking. At around 1 00 am I received a call from KP Gosavi instructing me that I should sign as pancha and called me to NCB office. I reached there and Sameer Wankhede instructed the staff to take my signatures and name. one Salekar from NCB told me sign on 10 blank papers. Salekar asked me my Adhaar details, as I was not carrying my adhaar card I asked him if I could send soft copy of the same to his whats app. I accordingly send my adhaar card soft copy from my cell no 9137566499 on whats app number 8167609712. After that he asked me to eat food and took one packet of food for the driver Vijay Suryavanshi.

12) After some time K.P. Gosavi came down and met one person named Sam d'souza at 500m away from NCB office. Sam D'souza spoke to KP Gosavi for 5 min and again after going around the NCB office the said Sam D'souza and K P Gosavi got down from the car and met again. After that KP Gosavi left in the white Innova and Sam dsouza's Innova crista followed us. Then we stopped at Lower Parel bridge near Big bazaar and Sam also stopped at the said location. Till such time we reached Lower parel K.P. Gosavi was talking to sam on the phone and stated that you put a bomb of 25 crores and lets settle at 18 final because we have to give 8 crores to Sameer Wankhede.



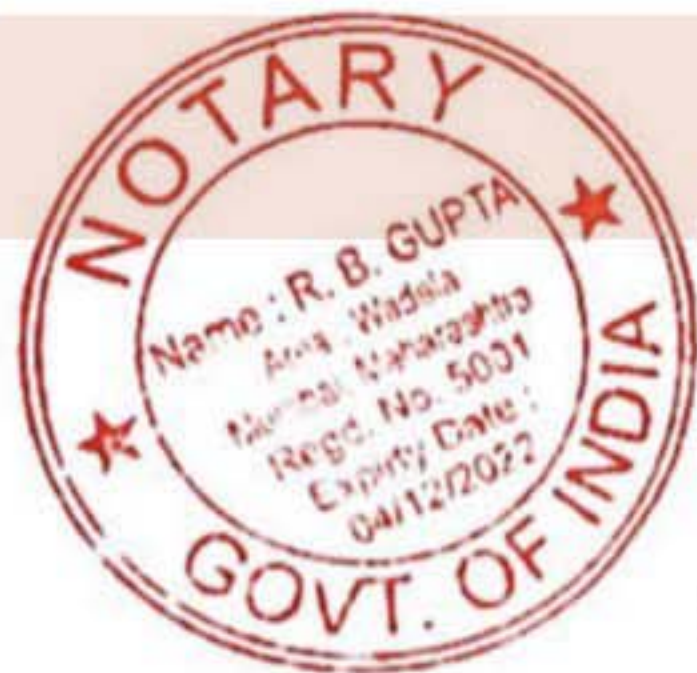


13) After a few minutes one blue colour Mercedes came to the spot and I saw Pooja Dadlani came in the car. Sam, K P Gosavi and Pooja Dadlani sat in the Mercedes and started talking. Then we all left after 15 min. K . P Gosavi and myself reached mantralaya. K.P. Gosavi spoke to someone and again left to Vashi. We reached Vashi and immediately KP told me to take Innova car and go to tardeo signal near Indiana hotel and collect 50 lacs Cash. I reached around 9 :45 a.m. at the said place where one white colour car no 5102 came and gave me 2 bags filled with cash. Which I took to Vashi at his home and gave it to Kiran Gosavi.

14) At that time I saw that Kiran Gosavi was packing bags and leaving somewhere. In the evening KP called him and told him to come near vashi bridge and thereafter changed location to inorbit mall where he came and gave the same bag of cash to me and told me to give it to sam.

15) Thereafter sam called me from mobile number 9700215203 at about 6 :15 pm and told me to come near Trident hotel. I reached trident hotel, where sam met me and I handed over the bag of cash to him in his car Innova crysta. However when he counted the cash it was only 38 lacs I left from there and I left to vashi.

16) I say that K P Gosavi is missing now and I now fear that NCB officials and other persons involved may kill me or abduct me



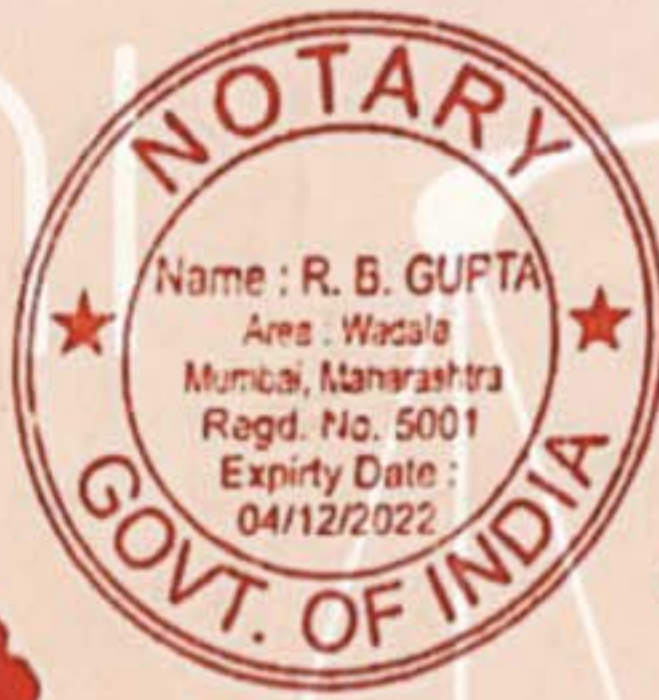
like K P Gosavi. As seen in the big cases ,witnesses often are killed or taken away and I therefore want to state the truth.
